## Changes on the Trust

The Nurses' Memorial Chapel Trust, which is responsible for the protection and administration of the Chapel, is made up of representatives of the Friends of the Chapel, NZ Historic Places Trust, NZ Nurses' Association, Returned Services Association, Canterbury Area Health Board, Civic Trust and up to two co-opted members. It in turn delegates the management of the Chapel to the Friends of the Chapel who over the years have done a really wonderful job in this capacity. The system works well and meets all the legal requirements.

Recently the Trust accepted the resignation of Bill Utley with considerable regret. Bill was one of the "originals" to sign the Trust document and then served on the Trust for all of its 17 years. During that time he rarely missed a meeting, was a valuable contact with the Area Health Board and always took an interest in Chapel activities. In Jennie Hamilton's words Bill was "always a very positive influence and we really valued his support".

The task of saving the Chapel was no easy one. If it hadn't been for the vigour and determination of the group led by Jennie and Fiona Ciaran, it clearly would not have happened. They were up against a Board that wanted to demolish the Chapel to make way for the rebuilding programme. At the time Bill had been on the Board since 1970, was chairman of their Works Committee and was bound by the Board decision. After the Minister of Conservation issued a Protection Notice to save the Chapel and the Board's plans changed, his readiness to serve on the Trust and his support since speaks for itself.

Bill's place on the Trust, representing the Area Health Board, has been taken by David Morrell who is a current member of the Board. For many years David served as a Hospital Chaplin and more recently he will be remembered as the manager of the Christchurch City Mission.

The two remaining "originals" still on the Trust are Jennie Hamilton and Pam Wilson. As Regional Officer at the Historic Places Trust in 1989, Pam worked hard to get the Protection Notice on the Chapel as quickly as possible and it was this move that ensured that the Chapel was left intact.
